Statement of Agreement For the Use of Facilities as Mass Immunization / Prophylaxis Center

This agreement is made and entered into between <u>Miami University</u>, Butler County, State of Ohio and the Butler County Health Department (BCHD).

Recitals

Pursuant to the terms of Ohio Revised Code statutes, the BCHD provides public health care, including emergency services in behalf of individuals and families who are potential victims of infectious disease outbreak or disaster. The Miami University Physical Facilities Department is authorized to permit the BCHD to use the facilities, equipment and grounds for administering and/or dissemination of pharmaceuticals and information required in the conduct of BCHD activities, and wishes to cooperate with the BCHD for such purposes.

The parties hereto mutually desire to reach an understanding that will result-in making the aforesaid use. Now, therefore, it is mutually agreed between parties as follows:

- 1. <u>Miami University</u> agrees that, after meeting its responsibilities to its faculty, staff and students it will permit, to the extent of its ability and upon request by the BCHD, the use of its physical facilities by the BCHD as a Mass Immunization / Prophylaxis Center for the victims of infectious disease outbreaks, bio-terrorism incidents, or other disasters.
- 2. The BCHD agrees that it shall exercise reasonable care in the conduct of its activities in such facilities and further agrees to replace or reimburse the Facility for any supplies or materials that may be used or destroyed by the BCHD in the conduct of its operations in said Mass Immunization/ Prophylaxis Center. No modifications or changes will be made to the facility without the expressed written approval of the Miami University Vice President for Finance and Business Services. Prior to occupancy of the Facility, representatives of both parties will inspect the structure and note any gross damage. Prior to vacating the Facility, representatives of both parties will inspect the structure and note and additional gross damage. BCHD will be responsible for any additional gross damage. Normal wear and tear is the responsibility of the Facility.
