FIRST AMENDMENT TO MASTER LICENSE AGREEMENT

WHEREAS, the parties wish to replace two (2) of the Cash Dispensing ATMs with Multi-Function ATMs: and

WHEREAS, the parties agree that University shall pay a fee for having these two new Multi-Function ATMs on its campuses; and

WHEREAS, the parties agree that they will be bound by the terms and conditions hereof.

NOW, THEREFORE, in consideration of the covenants, promises and representations set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Schedule "A" to Exhibit "A" of the Agreement, entitled "ATM LOCATIONS", shall be deleted in 1. its entirety and replaced with the Schedule attached hereto.

2. A new subsection 7(b)(vi) shall be added to the Master License Agreement, as follows:

pay a fee of \$1,400 per month to PNC Bank for the Multi-Function ATMs on the "(vi) University's Middletown and Hamilton campuses."

All provisions and terms and conditions of the Agreement not specifically addressed herein are 3. hereby ratified and reconfirmed by the parties.
