8	ACADEMIC SAFEGUARDS AND RESPONSIBILITIES
9	The Miami University and FAM, AAUP-AFT, reaffirm their long tradition of, and deep
10	commitment to, academic freedom and incorporate the Miami University Mission Statement
11	(2023) into this agreement.
12	
13	The administration recognizes the faculty of the University, vesting in it and, subject to approval
14	by the Board of Trustees, granting it the power to make its own regulations through University
15	Senate governing programs, the courses of instruction to be offered (including the modality and
16	the appropriate time frame within which to offer them), conditions of instruction, grading policy,
17	recommendations for degrees, honors and prizes, and other fundamental areas of curriculum and
18	instruction. Important or structural alterations that affect the quality of instruction or the
19	conditions of education for students or faculty must be subject to departmental, divisional, and
20	university shared governance provisions and ultimately University Senate review and approval.
21	
22	ASSOCIATION RIGHTS
23	
24	The University and FAM, AAUP AFT recognize that each has a responsibility for the
25	administration of this agreement.
26	
27	The University agrees that all Union Members shall have the right to organize freely, including
28	to join and to support FAM, AAUP-AFT for the purpose of engaging in collective bargaining.
29	There shall be neither discrimination by the Board or Administration because of FAM, AAUP-
30	AFT membership, nor shall any attempt be made to discourage membership in FAM, AAUP
31	AFT.

33	Section 1. Access to Information and resources for Contract Implementation

35	A. The University will continue to mervide FAM AAUD AFT with concess of mythelly spread to

the enforcement or negotiation of this Agreement and future Agreements, including, but not
limited to, any and all budgets, financial reports, and student enrollment data.

52 C.-FAM, AAUP-AFT shall be afforded the privilege of contracting for University services and
53 facilities as may be contracted for by other campus groups or organizations, at the same cost
54 regularly assessed for student groups.

56 D. FAM, AAUP-AFT will be furnished with information regarding Board of Trustee meetings
57 and actions in accord with Ohio's open meeting and public records laws. FAM, AAUP-AFT
58 shall be furnished with a copy of the minutes of each meeting of the Board of Trustees and other
59 public documents issued by the Board. Agenda of public meetings shall be made available to the
60 FAM, AAUP-AFT at the same time they are made available to the Board.

- 65 Section 2. Union Dues

- 67 A. The University will deduct regular union dues, fees, fines, and assessments
- 68 established under the terms of the FAM, AAUP-AFT Constitution, using payroll deduction for
- 69 FAM, AAUP AFT members, upon presentation of a signed, written deduction authorization by
- 70 the FAM, AAUP-AFT member. All deductions, together with an alphabetical list of names of
- 71 members of the FAM, AAUP AFT whose dues or fees have been deducted, shall be transmitted
- 72 to FAM, AAUP AFTT no later than the fifteenth (15th) of the following month, and, upon
- 73 receipt, FAM, AAUP-AFT shall assume full responsibility for the disposition of all funds
- 74 deducted. The University shall assess no charge upon FAM, AAUP-AFT for the administering of
- 75 these deductions.

77	B. Questions regarding dues, fees, or other deduction shall be resolved between the claimant and
78	the AAUP or AFT, and a refund, if appropriate, shall be made by the AAUP or AFT.

80	Section 3. Service Recognition
81	
82	For purposes of service recognition only, all University committees and administrators
83	evaluating Union Member performance shall consider and credit service to the local FAM,
84	AAUP-AFT union in the same manner as they consider and credit service to the University and
85	shall consider and credit service to the state and national AAUP/AFT in the same manner as they
86	consider and credit service to all other professional associations.
87	
88	The University will allow the full-time use of a room for union officers and designated union
89	representatives, including office and storage space exclusively for the use of FAM, AAUP-AFT,
90	and non-exclusive conference room space, as well as a telephone line, data line, and access to the
91	University's secured network.
92	
93	The University shall grant FAM, AAUP-AFT six (6) course releases per year of at least three (3)
94	credit hours each for the purposes of release time to administer FAM, AAUP-AFT, which shall
95	determine when and to whom the course releases are to be allocated, provided, however, that no
96	Union Member shall receive more than two (2) course releases per semester pursuant to this
97	Section. FAM, AAUP-AFT may purchase up to six (6) additional course releases at the course
98	overload rate.
99	
100	Members of the bargaining unit may be employed or act as independent contractors with other
101	entities including colleges and universities. The relationship between the University and
102	members of the bargaining unit is not exclusive. ; such mBargaining unit members are free to
103	perform academic and other responsibilities work in other capacities as long as they fulfill
104	contractual obligations to the University.

107	Section 4: Adequate Facilities
108	
109	The University and the FAM, AAUP-AFT recognize that an adequate educational environment
110	and supporting services both in person and online are necessary for effective teaching
111	effectiveness, learning, scholarly/creative activity, and service, consistent with the University's
112	mission.

114	4.1.1 The University shall provide each member of the unit with healthy, accessible, safe, and
115	clean conditions of work. Levels of technical, professional, clerical, and other support services
116	shall be comparable to peer institutions. The University shall make a good faith effort to provide
117	to each Faculty Member space and facilities adequate for effective and safe teaching, research,
118	advising, and all other activities necessary to their academic discipline.
119	
120	4.1.2 Libraries. The University recognizes its research mission and shall make a good faith effort
121	to provide library systems responsive to the Faculty and student needs consistent with standards
122	of quality recognized at a national level.
123	
124	4.1.3 Supplies and Equipment. The University recognizes that adequate budgets for supplies and
125	equipment are essential for high-quality instruction.
126	
127	4.1.4 Research Support. The University recognizes the need to support faculty research and
128	scholarly activity via funding for faculty, graduate, and undergraduate researchers. The
129	University shall make good faith efforts to increase these budgets to be consistent with that of
130	aspirational benchmarking universities.
131	
132	4.1.5 Support Personnel. The University recognizes the need for adequate budgets for support
133	personnel providing services within Academic Units.
134	
135	4.1.6 Parking, Dining, Meeting Space. The University shall ensure (1) adequate free parking for
136	faculty; (2) that at each campus there shall be cafeteria service to the extent possible; (3)
137	substantial Faculty involvement in the decision to renew food service contracts; (4) adequate
138	meeting rooms.
