UNION ACCESS TO INFORMATION AND FACILITIES

I. Bargaining Unit Information

1. The University will provide, at the Union's request and no more than once per fall and spring semester, the following information, if available and/or maintained by the University, for all bargaining unit faculty members, at no cost to the Union and in a mutually agreeable format:
 - a. Name;
 - b. Home or mailing address;
 - c. Email address;
 - d. Phone number;
 - e. Academic school, campus, and department, as applicable;
 - f. Rank;
 - g. Tenure status (tenure-track, tenured, or TCPL);
 - h. Gender;
 - i. Race and ethnicity;
 - j. Hire date;
 - k. Begin and end dates of contract term, as applicable;
 - l. Base annual salary; and
 - m. Leave status.
2. The Union may request the above information no earlier than September 15 for the fall semester and February 15 for the spring semester, respectively.
3. The University shall notify the Union of approvals and denials of promotion or tenure no later than June 1.

II. Orientation

The Union shall be provided an opportunity to meet with newly hired bargaining unit faculty members after the completion of new faculty orientation.

H.III. Use of Facilities

~~From time to time, t~~The Union may request the use of certain University facilities and/or services for the purpose of conducting meetings or other Union-related business. Based on availability, the University will permit the Union to use such facilities and/or services on the same terms, including all customary fees and charges, as other ~~non-University~~university or student groups. ~~The Employer reserves the right to add or modify customary fees charged for the use of rooms, at its discretion.~~

The Union reserves the right to add to, delete from, alter or amend this proposal. This proposal is made without precedent or prejudice to existing rights and entitlements, regardless of the character or source of same. Any tentative agreements reached between the parties on any proposals shall not become final until (1) the parties have reached final agreement on a full collective bargaining agreement, and (2) the Union membership has ratified the full collective bargaining agreement.
