New Business

5. New Business

- a. Studio Art Bachelor in Studio Art Rob Robbins, Chair, Art (see attached slide presentation)
 Studio and visual arts happen at high level at the University. The proposed BA will go beyond the BFA (professional degree) that centers on more on studio practice. The BA will is more hybrid/flexible degree and allows students to apply their artistic interests in relation to a broader liberal arts education as opposed to being centered around a studio practice and will keep the Art dept. more competitive with peer institutions.
- b. GLG Environmental Earth Science, Bachelor of Science Todd Dupont, Associate Teaching Professor, Geology & Environmental Earth Science (see attached slide presentation)
 - i. This change will allow the department to replace the BA with a BS degree. Surveyed students indicates significant support for this effort. There will be more academic rigor, without being onerous and no new resources are needed to accomplish the shift.
 - ii. Some surprise was expressed that only a BA had been offered from the beginning.
 - Q: Why not continue with both a BA and BS rather than replacing the BA A: Concerns around increasing the curriculum have been raised by the administration and departments are making decisions accordingly.
- c. SLM Sport Communication and Media, Bachelor of Science in Sport Leadership and Management Brody Ruihley, Assistant Professor, Sport Leadership and Management (see attached slide presentation)
 - i. No additional faculty or resources are needed at this time. Athletics and alum will be actively involved in the development of this new major. This new major will support international support and reassurances were made that SLM faculty are globally focused.
 - ii. Some concerns were raised that MJF was not thoroughly involved and discussion around how the process could be in improved in making sure that cross-divisional program development is handled was debated. As it relates to the current major, SLM is committed to collaborating with MJF to ensure that the new program is successful.
