### **BELLARMINE UNIVERSITY SPORT: Women's Basketball**

This agreement is made and entered into the **5th day of May 2025** by and between **BELLARMINE UNIVERSITY** (hereinafter designated as the HOME TEAM) and **Miami University of Ohio** (hereinafter designated as the VISITING TEAM).

WITNESSETH that:

1. The said parties mutually agree to cause their respective varsity teams to meeting in **LOUISVILLE, KENTUCKY** on **Sunday, November 16th, 2025**, and then and there engage in a game of basketball. **Game time is 2:00PM ET.**
2. The eligibility of all players to participate in the game shall be governed by the rules and regulations of its own conference and the NCAA.
3. Ticket prices shall be set by the HOME TEAM.
4. The HOME TEAM agrees to pay the VISITING TEAM, as full and complete compensation, the fixed sum of **\$0** as a guarantee for playing said game.

6. The HOME TEAM agrees to furnish the VISITING TEAM **\_50\_ complimentary tickets**. The VISITING TEAM shall also be permitted to purchase **\_\_** additional tickets.
7. Either party failing to comply with the conditions of Article 1, either by cancellation or failure to appear, shall forfeit money the amount of \$20,000 unless such cancellation shall be by mutual consent in which case this agreement shall be null and void.
8. Officials for the game shall be assigned by the **ASUN CONFERENCE**.
9. In the event of fire, flood, hurricane, tornado, earthquake, war, invasion, hostilities, rebellion, insurrection, confiscation by order of the government, military or police authority or prohibitory or governmental authority or any other event or reason beyond the control of either party, including that of the ASUN Conference or the National Collegiate Athletic Association, making it impossible or impractical to play the game, both parties shall be relieved of any and all obligations of this agreement. This includes COVID related issues.
10. The following additional games shall be played under the same terms and conditions unless otherwise indicated on the following dates and times. **A return game in Oxford, Ohio in the 2026-27 season**

It is herein agreed that failure to fulfill this agreement by either party, without written consent of the other party constitutes a breach of contract and the breaching party shall be required to pay liquidated damages in the amount of \$20,000.
