THIS AGREEMENT, made, entered into and duplicated by THE OHIO STATE UNIVERSITY, on behalf of its DEPARTMENT OF ATHLETICS ("OSU") and between Miami University ("Visiting Team") on this 24th day of April, 2026 stipulates the following.

THIRD, that the officials will be assigned by the appropriate Conference or by the HOME TEAM and the officials' fee shall be paid by the HOME TEAM or the HOME TEAM'S Conference. In addition, the contest, including the eligibility of the participants, shall be governed by NCAA Rules and Regulations of the appropriate Conference.

FOURTH, the VISITING TEAM recognizes that OSU has assigned its live, over-the-air broadcast and cable television rights to the contest(s) to the Big Ten Conference, Inc. ("Big Ten"), which, in turn has contracted with certain television networks and cable broadcasters. The VISITING TEAM recognizes that the contest may be broadcast (in any medium now known or known in the future), in connection with such agreements, and that the VISITING TEAM is not entitled to receive any revenue with respect to such broadcasts. The VISITING TEAM may not televise the contest (in any medium now known or known in the future), including, but not limited to, over-the-air or the Internet.

FIFTH, If it becomes impossible to hold the Competition for reasons of power failure, strikes, severe weather conditions, riots, war, epidemics, pandemics, including further conditions arising out of the ongoing COVID-19 pandemic or other unforeseen catastrophes or disasters beyond the control of either party, including cancellations pursuant to the respective Team's Conferences, this Agreement may be terminated by either party, the Contest shall be canceled, and neither party shall be responsible to the other for any loss or damage. No such cancellation shall affect the parties' obligations as to subsequent games covered by the Agreement.

SIXTH the parties agree that this Agreement shall be governed by the laws of the State of Ohio, regardless of its place of execution. Any legal action arising under this Agreement shall be brought in a Court of competent jurisdiction in the State of Ohio.

SEVENTH, this Agreement is the whole Agreement between the two parties. Any additions or modifications must be in writing, and must be signed by both parties. The persons executing this Agreement on behalf of their respective institutions warrant that they are duly authorized to do so.

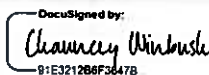

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, The Ohio State University (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

**To request paper copies from The Ohio State University**

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to [esignature@osu.edu](mailto:esignature@osu.edu) and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

**To withdraw your consent with The Ohio State University**

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to [swisher.169@osu.edu](mailto:swisher.169@osu.edu) and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

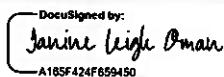
