the visiting teams acknowledge that this Memorandum of Agreement is being made during the time of the COVID-19 pandemic and that circumstances may arise beyond either party's control, to wit: Governmental (national, state and/or local), NCAA, or Conference regulations may preclude, either explicitly or practically, the engagement of either or both parties in the game. Should such regulations (i.e. the imposition of a 14-day quarantine prior to or immediately following participation in the game) arise between the date of execution of this Memorandum of Agreement and the start of the event described in paragraph 1, either party may withdraw from said game. Under these circumstances, the home team shall be permitted to cancel said game and the visiting team shall be permitted to withdraw from participation. Neither party shall be required to compensate the other and shall be relieved of all obligations benefits set forth elsewhere in this Memorandum of Agreement.
