2. Enroll full-time in a study abroad program during the fall or spring term.
3. Sign and submit this form.

Students are eligible to request the Study Abroad Airfare Grant no sooner than 180 days before their estimated departure date. If eligible, students will receive an airfare grant up to \$600. This grant is only available for one study abroad semester while attending Miami. In addition, students may request a university loan up to a maximum of \$600 to help finance the remainder of their ticket.

**Check the option requested:**

- Receive the \$600 Study Abroad Airfare Grant **only**
- Receive the \$600 Study Abroad Airfare Grant **and** also borrow an interest-free University Loan in the amount of \$\_\_\_\_\_ (\$600 max). A Promissory Note (promise to repay) for the University Loan must be completed (available at the One Stop about a week after accepting the loan).

If the Airfare Grant and/or University Loan is needed **in advance** of purchasing the ticket, students must visit the One Stop to complete a 180-Day Promissory Note (promise to repay) to receive the advanced funds. The approximate processing time for receiving the funds is 7-10 business days. Students will see an "**Airfare Grant**" and/or "**Short Term Loan**" charge on their Bursar Bill. This charge will be paid by their financial aid funds as long as the three steps above and the Consortium/Contractual Agreement form (if applicable) are completed. Funds for study abroad are disbursed in accordance with Miami's disbursement schedule. Visit [MiamiOH.edu/FinAid/StudyAbroad](https://MiamiOH.edu/FinAid/StudyAbroad) for more information.
