1. Submit a Free Application for Federal Student Aid (FAFSA) which computes student's financial need at FAFSA.gov.
 - Financial need is a student's Expected Family Contribution (EFC) minus the Cost of Attendance (COA).
 - Cost of attendance for students studying abroad will include any expenses related to the specific program.
2. Attend full-time during either the fall or spring semester in a study abroad program.
3. Submit the Airfare Grant Application with an estimate of the airline ticket cost or copy of receipt signed by the student.
 - Students must submit the printed receipt for the ticket before funds will be paid.
4. Complete the Consortium/Contractual Agreement and Transfer Credit Approval form, if studying in a Global Preferred or Approved program*. Agreement requires advisor's signature pre-approving course work.
 - Forms can be found online at MiamiOH.edu/OneStop/Forms

** Luxembourg and Exchange programs are exempt from the Consortium/Contractual Agreement.*

- If eligible, students will receive an airfare grant up to \$600. In addition, students may request a university loan up to a maximum of \$600 to help finance the remainder of their ticket. This grant is available to a student for one study abroad semester while attending Miami.
- Students are eligible to request the Study Abroad Airfare Grant no sooner than 180 days before their estimated departure date.
- The Office of Student Financial Assistance will notify students if they are eligible via their Miami email account.

Please check the option requested:

- Receive the \$600 Study Abroad Airfare Grant **only**
- Receive the \$600 Study Abroad Airfare Grant **and** also borrow an interest-free University Loan in the amount of \$ _____ (\$600 max). With the understanding that a separate Promissory Note for the University Loan must be completed.

This grant must be accompanied by a 180 Day Promissory Note (available at the One Stop) if requesting to receive the funds in advance of purchasing the ticket. The approximate processing time for receiving the money is 7-10 business days. The Office of the Bursar will charge an "Advance of Airfare Grant & Loan" on the student's Bursar Bill. This charge will be paid by the airfare funds detailed above 10 days prior to the start of the study abroad semester, as long as steps 1-4 above have been completed.

CERTIFICATION: I certify that all information reported to qualify for federal student aid is complete and correct and that purposely giving false or misleading information may lead to fines, prison or both. I further acknowledge that if I decide not to study abroad, I will be required to pay the entire amount of funds I received back to the University.
