The Council on Social Work Education requires a comprehensive approach to senior field practicum coordination, as this is our profession's signature pedagogy. The senior field experience is full-time in either the Spring or Summer semester and occurs during the last semester prior to BSW degree completion. Prior to 2019, students were required to complete 400-450 clock hours. In accordance with CSWE approval during pandemic years, hours were reduced to 400, which continues to be the required number of hours. The comprehensive coordination of this experience includes orientation of all pre-practicum students, a detailed application process, individual planning meetings with each student, coaching and preparation for agency interviews, oversight of the site match process, training and liaison work with agency field supervisors, agency relations and creation of new placement opportunities, and mediating any challenges that arise during placement.

Without FiftyForward's efforts, elders would face isolation, incur additional healthcare costs due to inactivity and having unmet needs, and be less engaged in assisting others to live their best lives. FiftyForward's budget annually exceeds \$4.4 million.
